ORDER

WHEREAS, WRC, NCTE had granted recognition/permission to NANASAHEB DR. UTTAMRAO MAHAJAN SHIKSHAN SHASTRA MAHAVIDYALAYA (B.ED.) RUN BY KISAN DNYANODAY MANDAL, DHULE ROAD, AT. KARGAON, TAL. CHALISGAON, JALGAON, MAHARASHTRA vide order dated 20.08.2008 to start the B.ED. course with an annual intake of 100 students.

AND WHEREAS, the letter for submission of AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution submitted affidavit vide letter dated 13.01.2015.

AND WHEREAS, Revised Recognition order was issued for two basic units of (50 students each) to the institution on 31.05.2015.

AND WHEREAS, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...issue Show Cause Notices to the institution of the condition maintained in revised order."

AND, WHEREAS, a Show cause notice was issued to institution on 01.12.2016 for not submitting compliance of Regulation 2014 required faculty staff list for two units and infrastructure.

AND WHEREAS, the matter was placed in 285th Meeting of WRC held on December 19-21, 2017 and the Committee decided that "...Show Cause Notice was issued to the institution on 01.12.2016. The institution has not replied so far.

Therefore, Recognition is withdrawn from the academic session 2018-2019."

AND WHEREAS, the Withdrawal Order was issued on 01.01.2018. The institution filed a appeal to the appellate authority Hqrs. dated 09.02.2018.

AND WHEREAS, the appeal order dated 05.06.2018, "...Committee concluded that the case deserves to be remanded back the case to W.R.C. for considering the reply of appellant institution. Appellant institution is required to submit a comprehensive reply to the points raised in S.C.N. within 15 days of the issue of appeal order and thereafter W.R.C. will issue appropriate or revised speaking order.

NOW THEREFORE, the Council hereby remands back the case of Nanasaheb Dr. Uttamrao Mahajan Shikshan Shastra Mahavidyalaya (B.Ed.) Run by Kisan Dnyanoday Mandal Dhule Road, At Kargaon, Tal. - Chalisgaon, Jalgaon, Maharashtra to the WRC, NCTE, for necessary action as indicated above."

AND WHEREAS, the matter was placed in 295th Meeting held on July 30 - 31, 2018 of WRC and the Committee decided that "... This is a case of appeal. The Appellate Authority vide order dated 05.06.2018 has remanded the case to WRC for further processing the application.

The WRC examined the file and found that the various documents which were required such as Building Completion Certificate from a Government Engineer, Staff profile approved by the Registrar have not been submitted.

Hence, show cause notice be issued as to why withdraw of recognition dt. 01.01.2018 should not stand. Reply should be received within one month."

AND, WHEREAS, the Show Cause Notice was issued to the institution and the reply of Show Cause Notice was received on 07.08.2018.



AND WHEREAS, the matter was placed in 296th Meeting of WRC held on August 28-29, 2018 and the Committee decided that "... The institution has submitted a staff profile approved by the Registrar dated 14.07.2018. In the list, it is seen that the lecturer at S.No.10 does not have the required NET/SET qualification. Further, 3 are part-time lecturers, which is not permitted under NCTE Regulations, 2014. As the staff is sufficient for one unit, intake is reduced from two units to one unit."

If institution contravenes any of the conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act 1993.

NOW, THEREFORE, the intake of the institution for conduct of B.Ed. course is hereby reduced from the intake of 100 students (2 basic units) to 50 students (one basic unit.)


